**TERMS OF AGREEMENT**

**RESIGNATION POLICY:**

**Full Membership Categories** may be cancelled with 30 days written notice and payment of all outstanding monies owed to the club.

**1 Year Introductory Membership Categories** are a 12 consecutive month commitment. Membership dues & charges will be billed on a monthly basis, however the dues times 12 months are owed in full to the club upon your Introductory Membership Expiration Date. Once a members signs up for these memberships they may not be resigned any earlier than the expiration date and payment on all dues through the expiration date must be paid in full.

**Summer Membership Categories** are a 6 consecutive month commitment. Summer House & Tennis Membership expire on September 30<sup>th</sup> and Summer Golf Memberships expire on October 31<sup>st</sup> – no exceptions. Once a members signs up for these memberships they may not be resigned any earlier than the expiration date and payment on all dues through the expiration date must be paid in full.
